# ON THE BUCHSBAUM INDEX OF RANK TWO VECTOR BUNDLES ON $\mathbb{P}^{3}$.

## 1. Introduction.

We work over an algebraically closed field of characteristic zero. Let $E$ be a rank two vector bundle on $\mathbb{P}^{3}$. The Buchsbaum index of $E$ is $b(E):=\min \{k \mid$ $\left.\mathfrak{m}^{k} \cdot H_{*}^{1}(E)=0\right\}$ (in the literature one often says that $E$ is " $k$-Buchsbaum"). By Horrock's theorem $b(E)=0$ if and only if $E$ is the direct sum of two line bundles. Then we have (see [8]):

Theorem 1. Let $E$ be a normalized rank two vector bundle on $\mathbb{P}^{3}$. (1) If $b(E)=1$, then $E$ is a null-correlation bundle.
(2) If $b(E)=2$, then $E$ is stable with $c_{1}=0, c_{2}=2$ (an instanton with $c_{2}=2$ ).

This classification is quite simple. However since every bundle is $k$-Buchsbaum for some $k$ it is clear that soon or later we will reach a point where the classification will be intractable. Since there were some echoes on Buchsbaum bundles during the conference we were curious to see if it was possible to push the classification a little bit further. Our result is as follows:

Theorem 2. let $E$ be a rank two vector bundle on $\mathbb{P}^{3}$ with $b(E)=3$. Then $E$ is stable and:
(i) if $c_{1}(E)=0, E$ is an instanton with $3 \leq c_{2}(E) \leq 5$. Moreover for any $3 \leq c_{2} \leq 5$, there exists an instanton, $E$, with $c_{2}(E)=c_{2}$ and $b(E)=3$.
(ii) if $c_{1}(E)=-1$, then $c_{2}=2$. Every stable bundle $E$ with $c_{1}=-1, c_{2}=2$ has $b(E)=3$.

This answers a conjecture made in [16]. The main tools we use are a restriction theorem (Theorem 6) to control $h^{0}\left(E_{H}(1)\right)$ in the stable case, some general properties (see Proposition 7) and a careful study of the minimal monad of Horrocks build from the minimal free resolution of the module $H_{*}^{1}(E)$.

[^0]In particular in Section 5 we investigate the minimal monad of "negative instantons" (a negative instanton is a stable bundle $E$ with $c_{1}(E)=-1$ and $h^{1}(E(-2))=$ $0)$. Contrary to what happens in the case of "positive" instanton $\left(c_{1}=0\right)$ the $H_{*}^{1}$ module is not necessarily generated by its elements of degree -1 , some generators of degree zero may occur. If $c$ denotes the number of generators of degree zero, it is easy to show that $c \leq c_{2} / 2$. In fact in a forthcoming paper ([7]) we prove:

Theorem 3. Let $E$ be a negative instanton with $c_{2} \geq 2$. Then $c \leq c_{2} / 2-1$. Moreover if $c=c_{2} / 2-1$, then $h^{0}(E(1))=1$. Finally for every $c_{2} \geq 2$ there exists a negative instanton with $c=c_{2} / 2-1$.

However to prove Theorem 2, we need this result just for $c_{2} \leq 6$. So to keep this paper self-contained we will prove this particular case with an ad-hoc argument (see Proposition 22, Corollary 28).

To conclude let us make this curious remark: every vector bundle $E$, with $1 \leq$ $b(E) \leq 3$ is an instanton (positive or negative).

## 2. Generalities.

A first bound on the Buchsbaum index of $E$ is given by the diameter of $H_{*}^{1}(E)$ :
Definition 4. The diameter of the indecomposable rank two vector bundle $E$ is $d(E):=c-c^{\prime}+1$, where $c=\max \left\{k \mid h^{1}(E(k)) \neq 0\right\}, c^{\prime}=\min \left\{k \mid h^{1}(E(k)) \neq 0\right\}$.

We have (see [3]):
Theorem 5. Let $E$ be a rank two vector bundle on $\mathbb{P}^{3}$, then $H_{*}^{1}(E)$ is connected (i.e. if $h^{1}(E(k))=0$ for some $k>c^{\prime}$, then $h^{1}(E(m))=0$ for $m \geq k$ ).

It follows that the diameter counts the number of non-zero (successive) pieces in the module $H_{*}^{1}(E)$ and that $b(E) \leq d(E)$.

The following result, which may be considered as a complement to Barth's restriction theorem, will play an important role:

Theorem 6. Let $E$ be a stable, normalized, rank two vector on $\mathbb{P}^{3}$ with $c_{2} \geq 4$. If $H$ is a general plane then: $h^{0}\left(E_{H}(1)\right) \leq 2+c_{1}$. In particular $h^{0}(E(1)) \leq 2+c_{1}$.

Proof. See [6].
Here we collect some general properties:
Proposition 7. Let $E$ be a normalized, rank two vector bundle on $\mathbb{P}^{3}$.
(1) Assume all the minimal generators of $H_{*}^{1}(E)$ are concentrated in one and the same degree (i.e. $H^{1}\left(E\left(c^{\prime}\right)\right)$ generates $\left.H_{*}^{1}(E)\right)$ ). Then $d(E)=b(E)$.
(2) Let $\alpha$ be the greatest degree of a minimal generator of $H_{*}^{1}(E)$. Then $h^{1}(E(n))=$ 0 , if $n \geq \alpha+b(E)$.
(3) If $E$ is stable, then $h^{1}(E(-k))=0$ for $k \geq b(E)$. Moreover $h^{1}(E(-b+1)) \leq$ $h^{0}\left(E_{H}(1)\right)$; if $c_{2} \geq 4$ then: $h^{1}(E(-b+1)) \leq h^{0}\left(E_{H}(1)\right) \leq 2+c_{1}$ ( $H$ a general plane).
(4) If $E$ is stable with $c_{1}=-1, c_{2} \geq 4$ and if $b(E) \geq 3$, then $h^{1}(E(-b+1))=0$.

Proof. (1) Assume $H^{1}(E(k))$ generates $H_{*}^{1}(E)$, then $c^{\prime}=k$. The natural map $H^{1}(E(k)) \otimes S^{c-k}(V) \rightarrow H^{1}(E(c))$ is surjective and non-zero. It follows that $b(E)=$ $c-c^{\prime}+1=d(E)$.
(2) We have the minimal free resolution: $\ldots \rightarrow \bigoplus S\left(-a_{i}\right) \oplus k . S(-\alpha) \rightarrow H_{*}^{1}(E) \rightarrow 0$, where $a_{i}<\alpha$. Twisting by $\alpha+b$ and using the fact that $\mathfrak{m}^{b} . \xi=0$ for any generator $\xi$, we get $H^{1}(E(\alpha+b))=0$. We conclude with Theorem 5 .
(3) It is enough to show $h^{1}(E(-b))=0(b=b(E))$. Since $h^{0}\left(E_{H}\right)=0$ by Barth's theorem if $H$ is a general plane, we have an injection $H^{1}(E(-b)) \stackrel{. H^{b}}{\longleftrightarrow} H^{1}(E)$. Since $. H^{b}=0, h^{1}(E(-b))=0$.

In the same way we have an injection $H^{1}(E(-b+1)) \stackrel{H^{b-1}}{\longleftrightarrow} H^{1}(E)$. Composing with $H^{1}(E) \xrightarrow{\cdot H} H^{1}(E(1))$ we must get zero, so the image of $H^{1}(E(-b+1))$ in $H^{1}(E)$ is contained in the kernel $K_{H}$ of $H^{1}(E) \xrightarrow{\text { H }} H^{1}(E(1))$. Since $H^{0}\left(E_{H}(1)\right)$ surjects $K_{H}$ we get $h^{0}\left(E_{H}(1)\right) \geq h^{1}(E(-b+1))$. We conclude with Theorem 6 .
(4) If $h^{1}(E(-b+1)) \neq 0$, by (3) $h^{1}(E(-b+1))=1$. Let $L$ be a general line. By combining $0 \rightarrow \mathcal{I}_{L} \rightarrow \mathcal{O} \rightarrow \mathcal{O}_{L} \rightarrow 0$ and $0 \rightarrow \mathcal{O}(-2) \rightarrow 2 . \mathcal{O}(-1) \rightarrow \mathcal{I}_{L} \rightarrow 0$ twisted by $E(-b+2)$ we get:


Taking cohomology since $h^{1}(E(-b))=0$ and $h^{0}\left(E_{L}(-b+2)\right)=0$ (indeed $E_{L}(-b+$ $\left.2) \simeq \mathcal{O}_{L}(-b+2) \oplus \mathcal{O}_{L}(-b+1)\right)$, we get $2 \cdot H^{1}(E(-b+1)) \hookrightarrow H^{1}(E(-b+2))$. It follows that the map $H^{1}(E(-b+1)) \otimes V \rightarrow H^{1}(E(-b+2))$ has an image, $W$, of dimension
at least two. Now we have an injective map $H^{1}(E(-b+2)) \stackrel{H^{b-2}}{\hookrightarrow} H^{1}(E)$. So $W^{\prime}:=. H^{b-2}(W) \subset H^{1}(E)$ has dimension at least two. Since $W^{\prime}$ has to be contained in the kernel, $K_{H}$, of $H^{1}(E) \xrightarrow{H} H^{1}(E(1))$ and since $h^{0}\left(E_{H}(1)\right) \geq \operatorname{dim}\left(K_{H}\right)$, we get a contradiction (see (3)).

We recall the following fact (see for instance [13] Prop. 3.1, this is stated for $c_{1}=0$ but works also for $c_{1}=-1$ ):

Lemma 8. Let $E$ be a stable, normalized, rank two vector bundle on $\mathbb{P}^{3}$. Let $\left\{k_{i}\right\}$ be its spectrum. Set $k_{+}=\max \left\{k_{i}\right\}$. Then $H_{*}^{1}(E)$ is generated in degrees $\leq k_{+}-c_{1}-1$.
Let $\rho(k)$ denote the number of minimal generators of $H_{*}^{1}(E)$ in degree $k$, then: $\rho(-1-j) \leq s(j)-1$, for $0 \leq j \leq k_{+}$(here $s(j)=\#\left\{j \mid k_{i}=j\right\}$.

Finally let us recall Horrock's construction of the "minimal monad" for a rank two vector bundle $E$ on $\mathbb{P}^{3}$ with $-1 \leq c_{1} \leq 0$. Let

$$
\cdots \rightarrow L_{2} \rightarrow L_{1} \rightarrow L_{0} \rightarrow H_{*}^{1}(E) \rightarrow 0
$$

be the minimal free resolution. Then $L_{1} \simeq L_{1}^{*}\left(c_{1}\right), L_{2}$ has a direct summand isomorphic to $L_{0}^{*}\left(c_{1}\right)$ which induces a minimal monad

$$
\tilde{L}_{0}^{*}\left(c_{1}\right) \hookrightarrow \tilde{L}_{1} \rightarrow \tilde{L}_{0}
$$

whose cohomology is $E$. Furthermore $r k\left(L_{1}\right)=2 r k\left(L_{0}\right)+2$. See for instance [15], [4], 13].

## 3. Unstable bundles.

First of all let us recall the following useful fact:
Lemma 9. Let $\mathcal{E}$ be a rank two vector bundle on $\mathbb{P}^{3}$ with $c_{1}(\mathcal{E})=c_{1}$. Assume $\mathcal{E}$ has a section vanishing in codimension two. If $h^{0}\left(\mathcal{E}_{H}\left(-c_{1}+1\right)\right) \neq 0$ for $H$ a general plane, then $\mathcal{E}$ is the direct sum of two line bundles.

Proof. We have an exact sequence: $0 \rightarrow \mathcal{O} \rightarrow \mathcal{E} \rightarrow \mathcal{I}_{X}\left(c_{1}\right) \rightarrow 0$, where $X \subset \mathbb{P}^{3}$ is a curve. The assumption implies $h^{0}\left(\mathcal{I}_{X \cap H}(1)\right) \neq 0$, for $H$ a general plane. By a result of Strano $([17])$ this implies $(\operatorname{ch}(k)=0)$ that $X$ is a plane curve. So $H_{*}^{1}(\mathcal{E})=0$ and $\mathcal{E}$ is decomposed.

Remark 10. The assumption $\operatorname{ch}(k)=0$ is necessary, see [11].
From now on $E$ will denote a normalized, unstable rank two vector bundle. hence $h^{0}(E(-r)) \neq 0$ for some $r \geq 0$ and we will assume that $-r$ is the least twist having a section.

Lemma 11. With notations as above, if $b(E)=b$, then $h^{1}\left(E\left(r-b+1-c_{1}\right)\right)=0$. Moreover: $-2 b+2 r+6-c_{1} \leq 0$.

Proof. By assumption we have:

$$
0 \rightarrow \mathcal{O} \rightarrow E(-r) \rightarrow \mathcal{I}_{C}\left(-2 r+c_{1}\right) \rightarrow 0
$$

where $C$ is a curve with $\omega_{C}\left(4+2 r-c_{1}\right) \simeq \mathcal{O}_{C}$. In particular: $1-p_{a}(C)=d(4+$ $\left.2 r-c_{1}\right) / 2(*)$, where $d=\operatorname{deg}(C)$.

We may assume $h^{0}\left(\mathcal{I}_{C}(1)\right)=0$ (otherwise $E$ is decomposed). It follows that $h^{0}(E(k))=h^{0}(\mathcal{O}(k+r))$ if $k \leq r-c_{1}+1$. We may assume $h^{0}\left(\mathcal{I}_{C \cap H}(1)\right)=0$ if $H$ is a general plane (Lemma 9). Hence $h^{0}\left(E_{H}(k)\right)=h^{0}\left(\mathcal{O}_{H}(k+r)\right)$ if $k \leq r-c_{1}+1$. This shows that:

$$
0 \rightarrow E(k-1) \rightarrow E(k) \rightarrow E_{H}(k) \rightarrow 0
$$

induces an exact sequence on global sections if $k \leq r-c_{1}+1$. So $H^{1}(E(k-1)) \stackrel{\text { H }}{\hookrightarrow}$ $H^{1}(E(k))$ if $k \leq r-c_{1}+1$. Then $H^{1}\left(E\left(r-b-c_{1}+1\right)\right) \stackrel{. H^{b}}{\hookrightarrow} H^{1}\left(E\left(r+1-c_{1}\right)\right)$ is injective. Since $. H^{b} \equiv 0, h^{1}\left(E\left(r-b-c_{1}+1\right)\right)=0$.

It follows that $h^{1}\left(\mathcal{I}_{C}(-b+1)\right)=0=h^{0}\left(\mathcal{O}_{C}(-b+1)\right)$. This implies $\chi\left(\mathcal{O}_{C}(-b+\right.$ $1)) \leq 0$. Since $\chi\left(\mathcal{O}_{C}(-b+1)\right)=d(-b+1)-p_{a}(C)+1$, from $(*)$ we get: $-2 b+2 r-$ $c_{1}+6 \leq 0$.

This gives us the complete classification when $b \leq 3$ :
Proposition 12. There is no unstable rank two vector bundle $E$ with $1 \leq$ $b(E) \leq 3$.

Proof. From $-2 b+2 r+6-c_{1} \leq 0$ (Lemma 11), since $r \geq 0$ and $-1 \leq c_{1} \leq 0$, we see that if $b \leq 3$ the only possibility is $b=3, c_{1}=r=0$. So $E$ is properly semistable, with $h^{1}(E(-2))=0$ (Lemma 11). By Serre's duality we have $h^{2}(E(k))=0$ if $k \geq-2$. Also $E_{L} \simeq 2 . \mathcal{O}_{L}$ for a general line. Combining the exact sequences: $0 \rightarrow E(m) \otimes \mathcal{I}_{L} \rightarrow E(m) \rightarrow E_{L}(m) \rightarrow 0$ and $0 \rightarrow E(m-2) \rightarrow 2 . E(m-1) \rightarrow$ $E(m) \otimes \mathcal{I}_{L} \rightarrow 0$, we see that $2 . H^{1}(E(m-1)) \rightarrow H^{1}(E(m))$ is surjective. Hence $H_{*}^{1}(E)$ is generated by $H^{1}(E(-1)$. It follows (Proposition 7 ) that $d(E)=b(E)$. If $b(E)=3$, then $h^{1}(E(2))=0$. Finally we get $\chi(E(2))=h^{0}(E(2))=20-4 c_{2}$. Since $h^{0}(E(2)) \geq h^{0}(\mathcal{O}(2))=10$, we get $c_{2} \leq 2$. So the section of $E$ vanishes along a curve of degree two with $\omega_{C}(4)=\mathcal{O}_{C}$. So $C$ is a double line of arithmetic genus -3 . But the Hartshorne-Rao module of such a curve has diameter 5 .
4. Stable bundles with $c_{1}=0$ And $b=3$.

Let $E$ be a stable bundle with $c_{1}=0$ and $b(E)=3$. By Proposition $7, h^{1}(E(-3))=$ 0 and $h^{1}(E(-2)) \leq 2$. We will distinguish two cases: (a) $h^{1}(E(-2))>0$, (b) $h^{1}(E(-2))=0$.
4.1. Stable bundles with $c_{1}=0, b=3$ and $h^{1}(E(-2))>0$.

We first observe that by the properties of the spectrum ([10, 7.1, 7.2, 7.5) the spectrum of $E$ is of the form $\left\{-1^{u}, 0^{c_{2}-2 u}, 1^{u}\right\}$, where $u:=h^{1}(E(-2)) \leq 2$. It follows (Lemma 8) that $H_{*}^{1}(E)$ is generated in degrees $\leq 0$ and $h^{1}(E(3))=0$ (Proposition 7).

Lemma 13. Let $E$ be a stable rank two vector bundle with $c_{1}=0$ and $b(E)=3$. Then $c_{2}(E) \leq 8$ and if $H_{*}^{1}(E)$ is generated in degrees $\leq-1, c_{2}(E) \leq 5$.

Proof. As already said $h^{1}(E(3))=0$. This implies $\chi(E(3))=40-5 c_{2} \geq 0$, hence $c_{2} \leq 8$. If $H_{*}^{1}(E)$ is generated in degrees $\leq-1$, by Proposition 7 , we have $h^{1}(E(2))=$ 0 , this implies $\chi(E(2))=20-4 c_{2} \geq 0$, hence $c_{2} \leq 5$.

The following is well known ([5]) but for the convenience of the reader we include a proof:

Lemma 14. Let $E$ be a stable rank two vector bundle with $c_{1}=0$ and spectrum $\left\{-1,0^{c_{2}-2}, 1\right\}$. Then $H_{*}^{1}(E)$ is generated in degrees $\leq-1$. More precisely:
(i) If the natural map $\mu: H^{1}(E(-2)) \otimes V \rightarrow H^{1}(E(-1))$ is injective the minimal monad has the following shape:

$$
\left(c_{2}-4\right) \cdot \mathcal{O}(-1) \oplus \mathcal{O}(-2) \hookrightarrow\left(2 c_{2}-4\right) \cdot \mathcal{O} \rightarrow\left(c_{2}-4\right) \cdot \mathcal{O}(1) \oplus \mathcal{O}(2)
$$

(ii) If $\mu$ is not injective it has rank three and the minimal monad is:

$$
\left(c_{2}-3\right) \cdot \mathcal{O}(-1) \oplus \mathcal{O}(-2) \hookrightarrow \mathcal{O}(-1) \oplus\left(2 c_{2}-4\right) \cdot \mathcal{O} \oplus \mathcal{O}(1) \rightarrow\left(c_{2}-3\right) \cdot \mathcal{O}(1) \oplus \mathcal{O}(2)
$$

Proof. (i) We know that $M:=H_{*}^{1}(E)$ is generated in degrees $\leq 0$. If $\mu$ is injective there are $c_{2}-4$ generators of degree -1 and no relations in degree one. Since $L_{1} \simeq L_{1}^{*}$, by minimality $L_{1}=\alpha . S$ and we have: $\cdots \rightarrow \alpha . S \rightarrow a . S \oplus\left(c_{2}-4\right) . S(1) \oplus S(2) \rightarrow$ $M \rightarrow 0$. By minimality $a=0$ and the conclusion follows.
(ii) By Lemma $8, M$ has at most $c_{2}-3$ generators of degree -1 , so $\mu$ has rank $\geq 3$. If the rank is three there is one relation of degree one and we have:

$$
\cdots \rightarrow S(-1) \oplus \alpha . S \oplus S(1) \rightarrow a . S \oplus\left(c_{2}-3\right) . S(1) \oplus S(2) \rightarrow M \rightarrow 0
$$

The induced minimal monad is:

$$
\mathcal{O}(-2) \oplus\left(c_{2}-3\right) \cdot \mathcal{O}(-1) \oplus a \cdot \mathcal{O} \hookrightarrow \mathcal{O}(-1) \oplus \alpha \cdot \mathcal{O} \oplus \mathcal{O}(1)
$$

Since this is a minimal injective morphism of vector bundles we get $a=0$ and the conclusion follows.

Lemma 15. Let $E$ be a stable rank two vector bundle with $c_{1}=0, b(E)=3$ and $h^{1}(E(-2)) \neq 0$. Then the spectrum of $E$ is $S p(E)=\left\{-1^{2}, 0^{c_{2}-4}, 1^{2}\right\}$.

Proof. We have to show that $S p(E)=\left\{-1,0^{c_{2}-2}, 1\right\}$ is impossible. By Lemma 14 and Lemma $13, c_{2} \leq 5$.

If we are in case (ii) of Lemma 14 there exists a special plane $H_{0}$ such that $H^{1}(E(-2)) \xrightarrow{m_{H_{0}}} H^{1}(E)$ is zero. It follows that $h^{0}\left(E_{H_{0}}(-1)\right) \neq 0$. Since $h^{0}\left(E_{H}(-2)\right)=$ $0, \forall H$ (because $h^{1}(E(-3))=0$ ), the section of $E_{H_{0}}(-1)$ ) vanishes in codimension two: $0 \rightarrow \mathcal{O}_{H_{0}} \rightarrow E_{H_{0}}(-1) \rightarrow \mathcal{I}_{Z}(-2) \rightarrow 0$. We have $\operatorname{deg}(Z)=c_{2}+1$. Since $h^{1}(E(2))=0$ (because $b(E)=3$ and $H_{*}^{1}(E)$ is generated in degrees $\leq-1$ ), we get: $h^{1}\left(E_{H_{0}}(2)\right)=0$ (because $\left.h^{2}(E(1))=0\right)$. It follows that $h^{1}\left(\mathcal{I}_{Z}(1)\right)=0$, which is absurd since $c_{2} \geq 3$.

So we are necessarily in case (i) of Lemma 14, hence $c_{2} \geq 4$. If $c_{2}=4$, then $H_{*}^{1}(E)=(S / I)(2)$, where $I$ is a complete intersection of type $(2,2,2,2)$. It follows that $d(E)=b(E)=5$.

Assume $c_{2}=5$. The map $\left(S^{2} V \otimes\langle\xi\rangle\right) \oplus(V \otimes\langle\alpha\rangle) \rightarrow H^{1}(E)$ is surjective. Since $h^{1}(E)=8$, we deduce that the map $S^{2} V \otimes\langle\xi\rangle \rightarrow H^{1}(E)$ has an image, $W$, of dimension $\geq 4$. Since $b(E)=3$, if $H$ is any plane $H^{1}(E) \xrightarrow{m_{H}} H^{1}(E(1))$ has $W$ in its kernel, $K_{H}$. Since $h^{0}\left(E_{H}(1)\right) \geq \operatorname{dim}\left(K_{H}\right)$, this contradicts Theorem 6.

Now we turn to the case $S p(E)=\left\{-1^{2}, 0^{c_{2}-4}, 1^{2}\right\}$ (observe that necessarily $c_{2} \geq$ 5).

Lemma 16. Let $E$ be a stable rank two vector bundle with $c_{1}=0$ and $S p(E)=$ $\left\{-1^{2}, 0^{c-4}, 1^{1}\right\}\left(c:=c_{2} \geq 5\right)$. Then the minimal free resolution of $H_{*}^{1}(E)$ is:
$\cdots \rightarrow(8-e) \cdot S(-1) \oplus(2 c-10) \cdot S \oplus(8-e) \cdot S(1) \rightarrow(c-e) \cdot S(1) \oplus 2 \cdot S(2) \rightarrow H_{*}^{1}(E) \rightarrow 0$
where $5 \leq e \leq 8$. In particular $H_{*}^{1}(E)$ is generated in degrees $\leq-1$.
Proof. Since $\rho(-1) \leq s(0)-1=c-5$, the image of $H^{1}(E(-2)) \otimes V \rightarrow H^{1}(E(-1))$ has dimension $e \geq 5$. There are $c-e$ generators of degree -1 and exactly $8-e$ linear relations between the two generators of degree -2 . Hence the resolution has the following shape:

$$
\cdots \rightarrow \bigoplus S\left(b_{i}\right) \oplus(8-e) \cdot S(1) \rightarrow a \cdot S \oplus(c-e) \cdot S(1) \oplus 2 \cdot S(2) \rightarrow H_{*}^{1}(E) \rightarrow 0
$$

Since $L_{1}=\bigoplus S\left(b_{i}\right) \oplus(8-e) \cdot S(1)$ satisfies $L_{1} \simeq L_{1}^{*}$, we get $L_{1}=(8-e) \cdot S(-1) \oplus$ $\alpha . S \oplus(8-e) . S(1)$. Now the minimal monad provides a minimal injective morphism of vector bundles: $\mathcal{L}_{0}^{*} \hookrightarrow \mathcal{L}_{1}$. It follows (by minimality) that $a . \mathcal{O} \hookrightarrow(8-e) . \mathcal{O}(1)$. The quotient is a vector bundle with $H_{*}^{1}=0$ so it has to have rank $\geq 3$. This implies $8-e \geq a+3$. Since $e \geq 5$ it follows that $a=0$ : there is no generator of degree zero. So the resolution is:

$$
\cdots \rightarrow(8-e) \cdot S(-1) \oplus \alpha \cdot S \oplus(8-e) \cdot S(1) \rightarrow(c-e) \cdot S(1) \oplus 2 \cdot S(2) \rightarrow H_{*}^{1}(E) \rightarrow 0
$$

Since $2 . r k\left(L_{0}\right)+2=r k\left(L_{1}\right)$, we get the result.
We are close to the end:

Corollary 17. Let $E$ be a stable rank two vector bundle with $c_{1}=0$. If $b(E)=3$, then $E$ is an instanton with $3 \leq c_{2}(E) \leq 5$.

Proof. If $h^{1}(E(-2)) \neq 0$, by Lemma 15 the spectrum is $\left\{-1^{2}, 0^{c_{2}-4}, 1^{2}\right\}$. According to Lemma 16 if $E$ has such a spectrum, $H_{*}^{1}(E)$ is generated in degrees $\leq-1$. By Lemma 13, $c_{2} \leq 5$. So it remains to show that the case $S p(E)=\left\{-1^{2}, 0,1^{2}\right\}$ is impossible. By Lemma 8, $H_{*}^{1}(E)$ is generated by its degree -2 piece. Hence $d(E)=b(E)$ (Proposition 7). If $b(E)=3$, then $h^{1}(E(1))=0$ (Proposition 7). Since $\chi(E(1))=-7$, this is impossible.

### 4.2. Instanton bundles with $b=3$.

We recall that an instanton is a stable rank two vector bundle, $E$, on $\mathbb{P}^{3}$ with $c_{1}(E)=0$ and $h^{1}(E(-2))=0$. Equivalently $E$ is an instanton if it is stable and its spectrum is $\left\{0^{c_{2}}\right\}$. As it is well known $H_{*}^{1}(E)$ is generated by its degree -1 piece, hence (Proposition 7) $d(E)=b(E)$.

We recall an important result, due to Hartshorne-Hirschowitz ([12]):
Theorem 18. For every $c_{2} \geq 1$ there exists an instanton bundle with Chern classes $c_{1}=0, c_{2}$ and with natural cohomology (i.e. at most one of the four groups $H^{i}(E(k)), 0 \leq i \leq 3$ is non-zero, $\left.\forall k \in \mathbb{Z}\right)$.

Corollary 19. There exists an instanton bundle, $E$, with $b(E)=3$ if and only if $c_{2}(E) \in\{3,4,5\}$.

Proof. Since $\chi(E(2))=20-4 c_{2}$ is $<0$ if $c_{2} \geq 6$, we have $h^{1}(E(2)) \neq 0$, hence $d(E) \geq 4$. Since $b(E)=d(E)$ for an instanton, we conclude that if $b(E)=3$, then $c_{2}(E) \leq 5$.

If $E$ has natural cohomology $h^{1}(E(2))=0 \Leftrightarrow c_{2} \leq 5$. Moreover since $\chi(E(1))=$ $8-3 c_{2}, h^{1}(E(1)) \neq 0$ if $c_{2} \geq 3$. In conclusion, if $E$ has natural cohomology: $d(E)=3 \Leftrightarrow 3 \leq c_{2} \leq 5$. Since in any case $d(E)=b(E)$ for an instanton, we conclude.

Gathering everything together:
Proposition 20. Let $E$ be a stable rank two vector bundle with $c_{1}=0$. If $b(E)=3$, then $E$ is an instanton with $3 \leq c_{2}(E) \leq 5$. Moreover for any $3 \leq c_{2} \leq 5$ there exists an instanton, $E$, with $c_{2}(E)=c_{2}$ and $b(E)=3$.

## 5. Negative instanton bundles.

Let us start with a definition:
Definition 21. A negative instanton is a stable rank two vector bundle, $E$, with $c_{1}(E)=-1$ and $h^{1}(E(-2))=0$.

Equivalently $E$ is a negative instanton if it is stable with spectrum $\left\{-1^{c_{2} / 2}, 0^{c_{2} / 2}\right\}$. Although there are some analogies with the case $c_{1}=0$, the situation is quite different. For instance if $E$ is a negative instanton then $H_{*}^{1}(E)$ is not necessarily generated by its elements of degree -1 . All we can say is that $H_{*}^{1}(E)$ is generated in degrees $\leq 0$ (Lemma 8). We denote by $c$ the number of minimal generators of degree zero. Also we set $n:=c_{2} / 2$. To conclude the proof of Theorem 2 we will need in the next section the following:

Proposition 22. Let $E$ be a negative instanton with $4 \leq c_{2} \leq 6$, then $c \leq$ $c_{2} / 2-1$. Moreover if $c_{2}=4$ and $c=1$, then $h^{0}(E(1)) \neq 0$.

This is a particular case of the following result proved in [7]:
Theorem 23. Let $E$ be a negative instanton with $c-2 \geq 2$. Then $c \leq c_{2} / 2-1$. Moreover if $c=c_{2} / 2-1$, then $h^{0}(E(1))=1$. Finally for every $c_{2} \geq 2$ there exists a negative instanton with $c=c_{2} / 2-1$.

However to keep this paper self-contained we will proceed now to prove Proposition 22 with an ad-hoc argument (completely different from the one used in [7), see Corollary 28 .

Notice by the way that it is easy to get the bound $c \leq n$ : let $L$ be a general line. By combining $0 \rightarrow \mathcal{I}_{L} \rightarrow \mathcal{O} \rightarrow \mathcal{O}_{L} \rightarrow 0$, and $0 \rightarrow \mathcal{O}(-2) \rightarrow 2 . \mathcal{O}(-1) \rightarrow \mathcal{I}_{L} \rightarrow 0$, twisted by $E$, we get $2 . H^{1}(E(-1)) \xrightarrow{j} H^{1}\left(E \otimes \mathcal{I}_{L}\right) \xrightarrow{p} H^{1}(E)$. Now $j$ is injective and $p$ is surjective with $\operatorname{Ker}(p)=H^{0}\left(E_{L}\right)$. We conclude with Riemann-Roch.

### 5.1. Negative instantons with small Chern classes.

let $E$ be a negative instanton, we set $n:=c_{2} / 2$ and denote by $c$ the number of minimal generators of $H_{*}^{1}(E)$ of degree zero. We assume $c>0$. We know that $c \leq n$. The minimal monad is:

$$
\begin{equation*}
n \cdot \mathcal{O}(-2) \oplus c \cdot \mathcal{O}(-1) \hookrightarrow(c+n+1) \cdot \mathcal{O}(-1) \oplus(c+n+1) \cdot \mathcal{O} \rightarrow c \cdot \mathcal{O} \oplus n \cdot \mathcal{O}(1) \tag{1}
\end{equation*}
$$

The display of the monad is:


By minimality $\beta$ induces:

$$
\begin{equation*}
c . \mathcal{O}(-1) \stackrel{\tilde{\beta}}{\hookrightarrow}(c+n+1) \cdot \mathcal{O} \tag{2}
\end{equation*}
$$

Also $\alpha$ induces:

$$
\begin{equation*}
(c+n+1) \cdot \mathcal{O}(-1) \xrightarrow{\tilde{\alpha}} c \cdot \mathcal{O} \tag{3}
\end{equation*}
$$

The first main remark is:
Lemma 24. With notations as above, $\mathcal{E}:=\operatorname{Coker}(\tilde{\beta})$ is locally free.
Proof. By dualizing the display of the monad and since $E^{*}(-1) \simeq E$ we see that (up to isomorphism) $\alpha^{*}(-1)=\beta$ and also $\tilde{\alpha}^{*}(-1)=\tilde{\beta}$. Now we have an exact sequence:

$$
0 \rightarrow \mathcal{A} \rightarrow(c+n+1) \cdot \mathcal{O}(-1) \xrightarrow{\tilde{\alpha}} c \cdot \mathcal{O} \rightarrow 0
$$

where $\mathcal{A}$ is a vector bundle. By the above remark:

$$
0 \rightarrow c \cdot \mathcal{O}(-1) \xrightarrow{\tilde{\mathcal{B}}}(c+n+1) \cdot \mathcal{O} \rightarrow \mathcal{E} \simeq \mathcal{A}^{*} \rightarrow 0
$$

The map $\tilde{\alpha}$ yields the following commutative diagram:


The map $\psi$ need not be surjective. The snake lemma applied to the two bottom row of the diagram shows that: $\operatorname{Coker}(\lambda) \simeq \operatorname{Coker}(\psi)$. Let us define $J:=\operatorname{Im}(\psi)$.

Lemma 25. With notations as above:
(i) $h^{0}(K)=h^{0}(\mathcal{N})=h^{0}(E)=0$
(ii) $h^{0}(K(1)) \leq h^{0}(\mathcal{N}(1))=c+h^{0}(E(1)) \leq c+1$
(iii) $h^{0}(K(1)) \geq c$.

Proof. The first two statements follow easily from the display of the monad and the diagram above (taking into account that $h^{0}(E(1)) \leq 1$ by Theorem 6.

For (iii) consider the following diagram:


We have $\pi \circ j \circ i=0$ by the monad. So $s \circ p \circ i=0$. Since $s$ is injective $p \circ i=0$ and $c \cdot \mathcal{O}(-1) \stackrel{i}{\hookrightarrow} \mathcal{N}$ factors through $K$.

Corollary 26. With notations as above, if $\operatorname{rk}(J)=n$, then $c \leq n-1$. Moreover if $c=n-1$, then $h^{0}(E(1))=1$.

Proof. By Lemma 25 we have a commutative diagram:


Since $r k(J)=n$, we get $r k(\mathcal{J})=1$. By Lemma $24 \mathcal{E}$ is locally free. Since $J$ is torsion free, $\mathcal{J}$ is reflexive. So $\mathcal{J}=\mathcal{O}(a)$ and $K=c . \mathcal{O}(-1) \oplus \mathcal{O}(a)$. From $h^{0}(K)=0$ (Lemma 25), we get $a<0$. Now $c_{1}(J)=-c_{1}(K)=c-a$. Since $c_{1}(J) \leq n$ (because $J \subset n \cdot \mathcal{O}(1))$, we have $c=c_{1}(J)+a<n$. Finally if $c=n-1$, the only possibility is $c_{1}(J)=n, a=-1$. So $h^{0}(K(1))=c+1$ and we conclude with Lemma 25 .

Now we have the following simple lemma:

Lemma 27. Let $\mathcal{F}$ be a coherent sheaf of rank $r$ on $\mathbb{P}^{k}, k \geq 1$, such that $\mathcal{F} \subset n . \mathcal{O}_{\mathbb{P}^{k}}$. Then $h^{0}(\mathcal{F}(m)) \leq r . h^{0}\left(\mathcal{O}_{\mathbb{P}^{k}}(m)\right)$, for every $m \in \mathbb{Z}$. Moreover if there is equality for some $m \geq 0$, then $\mathcal{F}=r . \mathcal{O}_{\mathbb{P}^{k}}$.

Proof. We make a double induction on $k, m$. If $k=1, \mathcal{F}=\bigoplus_{i=1}^{r} \mathcal{O}_{\mathbb{P}^{1}}\left(a_{i}\right)$ with $a_{i} \leq 0$ and the statement follows immediately. Assume the Lemma proved for $k-1$. Since $\mathcal{F} \subset n . \mathcal{O}_{\mathbb{P}^{k}}, h^{0}(\mathcal{F}(-1))=0$. Let $H$ be a general hyperplane. We have $\mathcal{F}_{H} \subset n . \mathcal{O}_{H}$ and an exact sequence $0 \rightarrow \mathcal{F}(m-1) \rightarrow \mathcal{F}(m) \rightarrow \mathcal{F}_{H}(m) \rightarrow 0$. We get $h^{0}(\mathcal{F}) \leq h^{0}\left(\mathcal{F}_{H}\right) \leq r$. Then we conclude by induction on $m, m \geq 0$.

If $h^{0}(\mathcal{F}(m))=r \cdot h^{0}\left(\mathcal{O}_{\mathbb{P}^{k}}(m)\right)$ for some $m \geq 0$, then by descending induction $h^{0}(\mathcal{F})=r$. The evaluation map yields $0 \rightarrow r . \mathcal{O} \rightarrow \mathcal{F} \rightarrow \mathcal{G} \rightarrow 0$. The inclusion $r . \mathcal{O} \hookrightarrow n . \mathcal{O}$ shows that $\mathcal{G} \hookrightarrow(n-r) . \mathcal{O}$. Since $\mathcal{G}$ has rank zero, it follows that $\mathcal{G}=0$.

By considering $\mathcal{F}=r . \mathcal{O}_{\mathbb{P}^{k}}$ we see that the Lemma is sharp.
Now we turn back to $\mathbb{P}^{3}$ and the application we had in mind, i.e. the proof of Proposition 22:

Corollary 28. (1) Let $0 \rightarrow K \rightarrow(n+c+1) \cdot \mathcal{O} \rightarrow J \rightarrow 0$, be an exact sequence with $J \subset n \cdot \mathcal{O}(1)$. Assume $h^{0}(K(1)) \leq c+1$, with $c \leq n$. If $n \geq 2$, then $r k(J) \geq 2$. Moreover if $2 \leq n \leq 4$, then $c \leq n-1$ or $r k(J)=n$.
(2) Let $E$ be a negative instanton with $4 \leq c_{2} \leq 8$, then $c \leq c_{2} / 2-1$, where $c$ is the number of minimal generators of degree zero of $H_{*}^{1}(E)$. Moreover if $c_{2}=4$ and $c=1$, then $h^{0}(E(1))=1$.

Proof. (1) We have $\left.h^{0}((n+c+1) \cdot \mathcal{O}(1)) \leq h^{0} K(1)\right)+h^{0}(J(1))$, hence $4(n+c+1) \leq$ $c+1+h^{0}(J(1))$. By Lemma 27; $h^{0}(J(1)) \leq 10 r$, where $r:=r k(J)$. It follows that $4 n+3 c+3 \leq 10 r$. Hence $r \geq 2$ if $n \geq 2$.

If $c=n$ we get $7 n+3 \leq 10 r$. If $r \leq n-1$, then $13 \leq 3 n$, hence $n \geq 5$.
(2) Follows from (1) above and Corollary 26.

## 6. Stable bundles With $c_{1}=-1$ and $b=3$.

In this section $E$ will denote a stable rank two vector bundle on $\mathbb{P}^{3}$ with Chern classes $\left(-1, c_{2}\right)$ and with $b(E)=3$. For such a bundle we have:

Lemma 29. With notations as above $h^{1}(E(-2))=0, h^{1}(E(3))=0$ and $c_{2} \leq 6$.
Proof. By Proposition 7 (iv), $h^{1}(E(-2))=0$. In particular (Lemma 8) $H_{*}^{1}(E)$ is generated in degrees $\leq 0$. By Proposition 7 (ii), we get $h^{1}(E(3))=0$. Since $h^{3}(E(3))=0$ it follows that $\chi(E(3)) \geq 0$. Since $\chi(E(3))=30-\left(9 c_{2}\right) / 2$, we get $c_{2} \leq 6$.

Since $c_{2}$ is even we are left with three cases: $c_{2} \in\{2,4,6\}$.

Lemma 30. Every stable rank two vector bundle, $E$, with $c_{1}=-1, c_{2}=2$ has $b(E)=d(E)=3$.

Proof. We have (14] Prop. 2.2) that $H_{*}^{1}(E)$ is concentrated in degrees $-1,0,1$ with $h^{1}(E(-1))=h^{1}(E(1))=1, h^{1}(E)=2$. The module $H_{*}^{1}(E)$ is isomorphic (up to twist) to the Hartshorne-Rao module of the disjoint union of two conics, such a module is generated by its lowest degree piece.

Concerning the case $c_{2}=4$ we first recall (see [1]):

Lemma 31. Let $E$ be a stable rank two vector bundle with $c_{1}=-1, c_{2}=4$, then $h^{1}(E(2))=h^{0}(E(2)) \neq 0$.

Proposition 32. Let $E$ be a stable rank two vector bundle with $c_{1}=-1, c_{2}=4$. Then $b(E) \geq 4$.

Proof. From Lemma 31 it turns out that $d(E) \geq 4$. The module $H_{*}^{1}(E)$ is generated in degrees $-1,0$. If there is no generator in degree 0 then by Proposition 7. $b(E)=d(E)>3$. So we may assume that $H_{*}^{1}(E)$ has some generator of degree zero, i.e. (Corollary 28 ) one generator of degree zero. So the image, $W$, of $\mu: H^{1}(E(-1)) \otimes V \rightarrow H^{1}(E)$ has dimension 4. Furthermore, always by Corollary $28, h^{0}(E(1))=1$. If $H$ is a general plane we have $0 \rightarrow \mathcal{O}_{H} \rightarrow E_{H}(1) \rightarrow$ $\mathcal{I}_{Z}(1) \rightarrow 0$, where $\operatorname{deg}(Z)=4$ and (Theorem 6) $h^{0}\left(\mathcal{I}_{Z}(1)\right)=0$. It follows that $h^{1}\left(\mathcal{I}_{Z}(2)\right)=h^{1}\left(E_{H}(2)\right)=0$. Moreover the exact sequence $0 \rightarrow E \rightarrow E(1) \rightarrow$ $E_{H}(1) \rightarrow 0$ yields an inclusion $H^{1}(E) \hookrightarrow H^{1}(E(1))$. Let $W^{\prime} \subset H^{1}(E(1))$ be the image of $W$. The assumption $b(E)=3$ implies that $W^{\prime}$ is contained in the kernel of $H^{1}(E(1)) \xrightarrow{H} H^{1}(E(2))$. It follows that $h^{0}\left(E_{H}(2)\right) \geq 4$. In conclusion we have: $\cdots \rightarrow H^{0}\left(E_{H}(2)\right) \rightarrow H^{1}(E(1)) \xrightarrow{\varphi} H^{1}(E(2)) \rightarrow 0$ and $W^{\prime} \subset \operatorname{Ker}(\varphi)$. Ву Riemmann-Roch $h^{1}(E(1))=6$. Since $h^{0}(E(1))=1$, we get $h^{0}(E(2)) \geq 4$, hence (Lemma 31,,$h^{1}(E(2)) \geq 4$. It follows that $\operatorname{dim}(\operatorname{Ker}(\varphi)) \leq 2$. This is a contradiction since $\operatorname{dim} W^{\prime}=4$.

Finally let's turn to the last case $c_{2}=6$. First we have:
Lemma 33. let $E$ be a stable rank two vector bundle with $c_{1}=-1$. Assume $h^{1}(E(3))=0$ and $h^{1}(E(-2))=0$. If $L$ is a line and if $E_{L} \simeq \mathcal{O}_{L}(a) \oplus \mathcal{O}_{L}(-a-1), a \geq$ 0 , then $a<4$.

Proof. Assume $a \geq 4$ for some line $L$. The exact sequence $0 \rightarrow \mathcal{I}_{L} \otimes E \rightarrow E \rightarrow E_{L} \rightarrow$ 0 shows that $h^{1}\left(\mathcal{I}_{L} \otimes E(-a)\right) \neq 0$. Now consider the exact sequence: $0 \rightarrow E(-2) \rightarrow$ $2 . E(-1) \rightarrow \mathcal{I}_{L} \otimes E \rightarrow 0$. Since $h^{1}(E(-1-a))=0$, from $h^{1}(\mathcal{I} L \otimes E(-a)) \neq 0$, we get $h^{2}(E(-a-2)) \neq 0$. By duality $h^{2}(E(-a-2))=h^{1}(E(a-1))$. Since $a-1 \geq 3$, this is impossible $\left(h^{1}(E(3))=0\right.$ and Theorem 5).

We can now complete the proof of Theorem 2;
Proposition 34. Let $E$ be a stable rank two vector bundle with $c_{1}=-1, c_{2}=6$. Then $b(E)>3$.

Proof. First observe that, by Corollary 28, the natural map $\mu: H^{1}(E(-1)) \otimes V \rightarrow$ $H^{1}(E)$ has an image, $W$, of dimension $\geq 6$.

Assume $h^{0}\left(E_{H}(1)\right)=0$ for $H$ a general plane. Then we have $H^{1}(E) \hookrightarrow H^{1}(E(1))$. Let $W^{\prime}$ denote the image of $W$. Now twisting by one we have $\cdots \rightarrow H^{0}\left(E_{H}(2)\right) \rightarrow$ $H^{1}(E(1)) \xrightarrow{\varphi} H^{1}(E(2))$. If $b(E)=3$, then $W^{\prime} \subset \operatorname{Ker}(\varphi)$ and this implies $h^{0}\left(E_{H}(2)\right) \geq$ 6. Since $h^{0}\left(E_{H}(1)\right)=0, E_{H}(2)$ has a section vanishing in codimension two: $0 \rightarrow$ $\mathcal{O}_{H} \rightarrow E_{H}(2) \rightarrow \mathcal{I}_{Z}(3) \rightarrow 0(+)$, where $\operatorname{deg}(Z)=8$. Since $h^{0}\left(\mathcal{I}_{Z}(3)\right) \geq 5$ and $h^{0}\left(\mathcal{I}_{Z}(2)\right)=0, Z$ has seven points lying on a line $L$. Restricting the exact sequence to $L$ we get $E_{L}(2) \rightarrow \mathcal{O}_{L}(-4)$. It follows that $E_{L} \simeq \mathcal{O}_{L}(5) \oplus \mathcal{O}_{L}(-6)$. By Lemma 33 this is impossible. hence $b>3$ if $h^{0}\left(E_{H}(1)\right)=0$.

Assume $h^{0}\left(E_{H}(1)\right) \neq 0$. Then we have $0 \rightarrow \mathcal{O}_{H} \rightarrow E_{H}(1) \rightarrow \mathcal{I}_{Z}(1) \rightarrow 0(*)$, where $\operatorname{deg}(Z)=6$. By Theorem 6, $h^{0}\left(\mathcal{I}_{Z}(1)\right)=0$. With notations as above $W^{\prime} \subset$ $H^{1}(E(1))$ has $\operatorname{dim} W^{\prime} \geq 5$, hence $h^{0}\left(E_{H}(2)\right) \geq 5$. This implies $h^{0}\left(\mathcal{I}_{Z}(2)\right) \geq 2$. Since $h^{0}\left(\mathcal{I}_{Z}(1)\right)=0$, it follows that $Z$ has 5 points on a line $R$. Restricting (*) to $R$ we get: $E_{R}(1) \rightarrow \mathcal{O}_{R}(-4)$. it follows that $E_{R} \simeq \mathcal{O}_{R}(4) \oplus \mathcal{O}_{R}(-5)$; in contradiction with Lemma 33. So $b>3$ again.
